Shareholders that are entitled to attend the Meeting are given the opportunity to authorize their attendance and votes electronically by using e-Proxy on the eASY.KSEI system that can be accessed through https://easy.ksei.co.id.

Please be reminded that all Shareholder proposals to be included in the agenda of the Meeting, must comply with the provisions of Article 19 paragraph 6 of the Company's Articles of Association and Article 16 of POJK 15/2020 and must be received by the Company's Board of Directors at the latest on Monday, June 7, 2021.
